APPLICATION FOR TREE CUTTING AND REMOVAL PERMIT

Tree Cutting and Removal Permit Conditions:

1. BC Hydro and CityWest Telecommunications Company must be contacted regarding trees in proximity to hydro or telephone lines.

All tree cuttings must be removed from the site and either used for firewood, etc., or disposed of at the Landfill site.

2. No holes or other unsafe conditions are to be left where tree(s) stood previously. Temporary barricades are to be used when necessary.
3. Removal or topping of a tree over 100 mm (4 inches) in diameter, or from a height over 3 m (10 ft.) at the cut, shall be done by a registered faller with liability insurance and W.C.B. coverage.

4. The remaining stump of a topped tree shall be painted with a tar preservative or other appropriate coating.
5. All adjacent property owners or others who might benefit from the tree(s), as a privacy buffer must be contacted and their agreement (in writing) to the proposed work, be attached to this application.
6. No tree is to be reduced in height by more than 3.5 m (12 feet).
7. The Operations Department must be notified immediately prior to the start of the work. Inspections will be at the City's convenience. The Applicant is expected to strictly adhere to the conditions of this permit. Failure to do so may result in a Stop Work Order or significant fine.
